TOWN OF HANNIBAL REGULAR BOARD MEETING MAY 10, 2017 7:00 PM

Supervisor Ron Greenleaf called the meeting to order at 7:00pm with the Pledge of Allegiance to the Flag. Gregg Stupp, Jr. opened with a prayer.

Public Session:

- Tracy Pedder informed the board that since Infinity Enterprises cancelled the deal they had with the city of Fulton on the demolition of the Nestles Plant, the trucks have returned on Kelly Road. Code Enforcement Officer Wayne Newton responded stating that Mr. Lindsley was cleaning the trucks and they were not going to stay there. Councilman Gary Thompson also responded stating that the company should not be operating due to the loss of its Asbestos Removal License.
- Ellen Killicutt expressed concern that permits are issued after the work has been completed rather than before. She gave the example of a property on Route 34 that modified a used manufactured home and then classified it as a *working trailer* without first obtaining a permit. Code Enforcement Officer Wayne Newton responded stating that the gentleman was using the trailer as an office and for storage and that the Zoning Laws do not state anywhere that this is not allowed. It was pointed out by Planning Board Chairman Bob Dilts that if something is not listed in the Zoning Laws as "such" then it is implied that it is not permissible. Further discussion ensued with no resolution.
- County Legislator Terry Wilbur informed the Board that there were two confirmed cases of rabies in the County and that there are several Rabies Clinics offered throughout the County (the dates and places are posted near the Town Clerk's Window). He also provided Mosquito Repel Drops to be available to anyone who would like them. He stated that he would bring more as needed.
- County Legislator Terry Wilbur also informed the Board that the County is offering a Tire Amnesty Day where up to eight tires may be dropped off. He also reminded the public that the Fire Ban is in effect until May 15th.

Approval of the April Minutes: Supervisor Ron Greenleaf requested a motion be made to approve the April Regular Board Minutes.

• Councilman Gary Thompson made a motion to accept the April Board Minutes; Councilman Virginia Wilbur seconded the motion.

• Supervisor Ron Greenleaf shared correspondence from the Association of Towns about the subject of *shared services*. Supervisor Ron Greenleaf stated that the Governor would like to see more consolidation and shared services among local governments. In a letter received by The Association of Towns (see attached), it is their opinion that consolidation would remove the voice of local government and the say of the people. It is also pointed out that the Towns are already participating in *shared services* in many areas, such as Highway projects.

• After a discussion on proposing an increase to the water rates, Supervisor Ron Greenleaf made a motion to hold a Public Hearing on June 14th, 2017 at 7:30pm to discuss increasing the basic water rate from \$27.50 per 8,000 gallons to \$28.00 per 8,000 gallons and to increase the overage usage charge from \$1.90 to \$2.00; seconded by Councilman Randy Hendricks.

• Supervisor Ron Greenleaf asked Sherry Crosek to explain the need for the Town to take over the responsibility for the maintenance of Bethel Cemetery. She explained some of the responsibilities, such as mowing the cemetery and digging the graves. She also explained that at this time, no one is available to take this responsibility. After some discussion, Supervisor Ron Greenleaf asked for a motion allowing the Town to take responsibility for the maintenance of Bethel Cemetery.

Councilman Gary Thompson made a motion for the Town Board to authorize Supervisor Ron Greenleaf to begin the process allowing the Town to take responsibility for the maintenance of Bethel Cemetery; seconded by Councilman Rick Shoults.
