# TOWN OF HANNIBAL REGULAR BOARD MEETING JULY 12, 2017 7:00 PM

Supervisor Ron Greenleaf called the meeting to order at 7:00pm with the Pledge of Allegiance to the Flag. Gregg Stupp, Sr. opened with a prayer.

# **Public Session:**

- Bob Dilts gave an explanation of the reasons the Committee reviewing the Zoning Laws made the suggested changes presented at the Public Hearing last month. He also explained that any changes passed would only affect new permits or when a change occurs to an existing permit. A letter from the DEC was presented which stated that the hours of operation for mining, excavating, grading, processing operations, stockpiling operations, haulage operations and maintenance operations shall be limited to Monday through Friday from 7:00am to 5:00pm and Saturdays from 8:00am to 2:00pm (prohibited operation on Sundays and legal holidays). He questioned the need to form a second committee proposed by the Town Supervisor to review the proposed changes the volunteer committee had made.
- Kim Malone reprimanded the board members and officials who had made negative comments about the committee who worked on the review of the Zoning Laws.
- Larry Flint distributed a copy of Town Law Statue 271 to support his argument that the Committee to Review the Town Zoning Laws containing Planning Board members was not illegal as alleged by some board members.
- Kelly LaRock reminded the Board that the proposed changes to the Zoning Laws are only recommendations and the Board has the final approval authority. She expressed concern that the Committee Chairman was not supportive of the committee during the discussion at the last Board Workshop. She also expressed disappointment that the Supervisor created dissention by supporting the process while the committee was in progress but then expressed disapproval of the final product at the last Board Workshop.
- Ellen Killicutt commended the committee for their hard work and dedication as they made the recommendations for changes to the Zoning Laws. She also stated that it is difficult for members of the public to attend the Board Workshops due to the meetings being held at 3:30pm.

# At 7:22pm Supervisor Ron Greenleaf opened the Public Hearing on Fracking.

# PUBLIC HEARING ON PROPOSED AMENDMENTS TO BAN HYDRO-FRACKING 7:22PM

Gregg Stupp, Sr. gave an overview of the effects Hydro-Fracking can have on the community both economically and financially. He stated that there were a lot of myths about the safety of Hydro-Fracking and that there still isn't any confirmation of exactly what chemicals may be put in the ground as a result. He stressed the importance of passing a local law now to ban Hydro-Fracking in the town of Hannibal.

- Ellen Killicut asked if NYS had already passed legislation to ban Hydro-Fracking. Supervisor Ron Greenleaf confirmed that NYS passed legislation in 2015 to ban Hydro-Fracking.
- Larry Flint presented the Board with a map showing the increased amount of natural gas wells in Chautauqua County, PA. The number had increased from 315 in 1962 to 4,403 presently.
- Gregg Stupp, Sr. pointed out that the proposed Zoning Laws to ban Hydro-Fracking are the same laws that were passed in the Town of Dryden, which were challenged by a gas company and were upheld in a court of law.
- Councilman Gary Thompson stated that he and his family vacationed in Pennsylvania and they were unable to drink the water due to contamination from Hydro-Fracking.
- Kelly LaRock stated that she supports a ban on Hydro-Fracking to protect the community's water.
- Jack Beckwith, Jr. asked the Board if the Town Attorney had reviewed the proposed amendments; Supervisor Ron Greenleaf stated that the Town Attorney had not yet reviewed it.

Councilman Gary Thompson made a motion to accept the proposed amendments to the Town of Hannibal Zoning Laws banning Hydro-Fracking in the Town of Hannibal; seconded by Councilman Randy Hendricks.

• Mike Pereira asked what will happen if the Town Attorney doesn't approve of the amendment; Supervisor Ron Greenleaf stated that the Board would then revisit the idea.

Councilman Gary Thompson made a motion at 7:40pm to close the Public Hearing on the Proposed Amendments to the Zoning Laws banning Hydro-Fracking; seconded by Councilwoman Virginia Wilbur.
