TOWN OF HANNIBAL REGULAR BOARD MEETING APRIL 12, 2017 7:00 PM

Supervisor Ron Greenleaf called the meeting to order at 7:00pm with the Pledge of Allegiance to the Flag. Jack Beckwith, Jr. opened with a prayer.

Public Session:

- Susan Woods, Dennison Road, informed the Board that they are experiencing water back-up on their road. She explained that last summer they had requested that the Highway Department cut back some dead branches hanging over the road, but instead all the trees, dead and healthy were cut down. The debris was never cleaned up and this spring the culvert has become plugged with the brush causing the water to rise over the road. She raised concerns over the stagnant water becoming a breeding ground for mosquitos. She stated that she has lived there for over 40 years and has never experienced any problems with the culvert or with flooding. Highway Superintendent George Ritchie responded that the trees were cut due to a call from them and that he will take care of the clean-up but there are 54 miles of town roads that he has to take care of and he will be busy in the Village for a couple of weeks.
- Ed Woods, Dennison Road, stated that he had called Highway Superintendent George Ritchie several times about the matter and that he has been given several excuses.
- County Legislator Terry Wilbur informed the board that the County Directories are available and he provided some for the public. He also stated that the County secured a million dollar grant from the Attorney General's Office for the land bank and they have hired the first executive director. Some of the other upcoming activities include a Blood Drive scheduled for Wednesday, April 19th, 2017 from 10:00am to 3:00pm at the County Office Building in honor of former Assemblyman Chesbro and Earth Week is scheduled for April 23rd through April 29th. He encouraged everyone to join together to clean up our communities.
