TOWN OF HANNIBAL REGULAR BOARD MEETING APRIL 18, 2018 7:00 PM

Supervisor Virginia Wilbur called the meeting to order at 7:00pm with the Pledge of Allegiance to the Flag; Town Clerk Denise Hafner opened with a prayer.

Public Session:

- Supervisor Virginia Wilbur explained that the public could make comments or ask questions during the Public Session as listed on the Board Agenda and that if someone has a comment or question during the business part of the Board Meeting, they are welcome to address either her or any member of the Board after the meeting is adjourned.
- Gregg Stupp, Sr. asked about the status of the Zoning Law changes and the updates to the Comprehensive Plan. Supervisor Virginia Wilbur explained that she has had other priorities but was hoping to move forward with approving the changes suggested soon. He also stated that the Planning Board would like to hire their own attorney to be present at their meetings and because he does not take the salary for his position he would be willing to put it toward the cost of the attorney.
- Bob Dilts stated that the Planning Board would like to hire their own attorney who has experience with zoning laws. Supervisor Virginia Wilbur will look into it.
- Barb Downing expressed concerns that the Auto Shop on Martville Road has potential code violations such as no fence enclosing the junk vehicles, an accumulation of scrap metal parts, no water provided on the property and too many unregistered cars on the property. She stated that this affects the value of the surrounding properties.
- Bob Dilts stated that he has attempted to talk with the Town Code Enforcement Officer about the situation and that he had recently met with him on April 13th in the Code Enforcement Office and explained the responsibilities of a Code Enforcement Officer to him.
- At this time, Supervisor Virginia Wilbur read a resignation letter received from Code Enforcement Officer Dave Hanford effective April 13th, 2018.

• After some discussion, Ellen Killicutt stated that she had met with Code Enforcement Officer Dave Hanford and found him to be very professional. She also pointed out that the permit for the disputed Auto Shop was granted before Mr. Hanford was appointed as the Code Enforcement Officer and that paperwork was missing from many of the files.
