# TOWN OF HANNIBAL REGULAR BOARD MEETING JUNE 12, 2019 7:00 PM

Supervisor Virginia Wilbur called the meeting to order at 7:00pm with the Pledge of Allegiance to the Flag.

#### **Public Session:**

- Supervisor Virginia Wilbur explained that a three minute limit will apply for those who wish to speak and a sign in sheet was provided.
- Randy Hall asked the Board if there were plans to repair Cooper Road. He stated that it was in bad shape again. Town Supervisor Virginia Wilbur stated that the Highway Superintendent would need to be informed. Councilwoman Brenda Wilson stated that he is aware of it.
- Mike Sullivan asked the Board if there were plans for OCWA to take control of the water department. He referred to discussions that had occurred during the 2017/2018 proposal of a new water district which failed when brought to a vote. Town Supervisor Virginia Wilbur stated that there were no current plans for OCWA to run the water department.
- Supervisor Virginia Wilbur closed the Public Session at 7:15pm.

- Finance Committee Update: It was mentioned that the Supervisor's Financial Report does not show enough details and that not all the department categories are on the report.
- Website Committee Update: Councilman Floyd Calkins reported that the 2018 AUD is now posted on the website under Town Documents and along with a map of Bethel Cemetery. Councilwoman Brenda Wilson stated that she is working on the Rules of the Cemetery and once completed she would like them to be posted on the website.
- Comprehensive Plan Committee Update: Councilman Rick Shoults and Councilman Charles Reed are still waiting to receive the maps for the Comprehensive Plan. After a discussion, Supervisor Virginia

Wilbur stated that the completed part will be given to the Town Attorney once the Board members have reviewed it.

- Councilwoman Brenda Wilson suggested getting input from the School District and the Hannibal Fire Department about obtaining security lighting for the Municipal Building and Parking lot and will present it to the July Board Meeting. Councilman Floyd Calkins also suggested discussing the possibility of obtaining a grant through the Court (JCAP Grant) to help. Further discussion will take place at the July Board meeting.
- Supervisor Virginia Wilbur informed the Board that when the Town's generator was serviced it was discovered that it needed some repairs. DM Shaver submitted a quote of \$1,099.40 to repair the generator. Supervisor Virginia Wilbur spoke with the Village Mayor and the Village Board agreed to pay for half of the cost for the repairs. Supervisor Virginia Wilbur requested a motion to have the generator repaired. Councilman Floyd Calkins made a motion to approve the following resolution; Councilman Charles Reed seconded.
