The meeting was called to order with the Pledge of Allegiance by Chairman Stupp at 7:00 PM. The minutes will be read at the end of this meeting.

PUBLIC HEARING was opened at 7:07 PM for the Upcraft minor subdivision Tax ID # 266.00-01-02 at 551 66 Road. There were no objections or discussions on the issue . The regular meeting then continued.

PUBLIC HEARING was closed by Chairman Stupp at 7:38 PM. A motion was made by Josh Bomgren to approve the Upcraft minor subdivision. Second Kelly LaRock. AYE: Kelly LaRock , Bob Dilts, Josh Bomgren, Greg Stupp, Tony Murabito All in favor. Bob Dilts gave the Upcrafts' the list of Oswego County requirements, to then file their paperwork. A decision form was completed and signed by the board, a copy of which is in the file.

COMMUNICATIONS- A letter of resignation was received and read from Sue deMey. Bob Dilts wished to give Sue many thanks for her dedicated years of service to the Planning Board and the Town of Hannibal.

The Town received a letter from the Hannibal School District concerning the building of the new school bus garage. Bob Dilts made a motion that any further public communications concerning the bus garage that comes to the Planning Board should be referred to the Hannibal School District. Josh Bomgren second. All in favor.

A letter was received by the Planning Board from Robert LaRock IE- The following information submitted on 6/6/2019 should be considered on any application submitted for 485 Harris Hill Road property for David Emmons. It was placed in the Emmons/Malone file.

The July 2019 Planning Board Meeting will be July 11, 2019 as the first Thursday of the month is July 4th- holiday.

Josh Bomgren handed out copies, to the board, of the judges ruling on the Hofmann/Emmons vs Town of Hannibal.

Attorney Michael Fogel introduced himself to the board at which time Kelly LaRock recused herself from the bench and Planning Board business at 7:55 PM. Attorney Fogel representing W.D. Malone states that a special use permit application was filed with the Town Clerk June 3, 2019. A large file was presented to the board members. Discussion then followed on the file contents. A motion was made by Greg Stupp second Tony to accept the application. The vote was AYE Gregg Stupp AYE Tony Murabito AYE Josh Bomgren NAY Bob Dilts. The motion was not carried. A motion was made by Bob Dilts to table the discussion- No second was received. The motion was denied. At the end of the Harris Hill Mine discussions Kelly LaRock returned to the bench and Planning Board business at 8:50 PM. There is no additional new business.
