Assistant Clerk: \$11.10/hr. to \$12.00/hr.	Tax Collector: \$3,606 to \$3,750 annually
Town Justices: \$9,175 to \$10,588 annually	Court Clerk: \$9,090 to \$12,345 annually
Assessor: \$15,000 to \$18,000 annually	Highway Superintendent: \$47,137 to \$55,120 annually
Code Enforcement: \$9,600 to \$12,000 annually	Ron Greenleaf/Water Operator: \$13.50/hr. to \$16.00/hr.
Chris Harris/Water Operator: \$13.50/hr. to \$16.00/hr.	John Congdon/Water Tester: \$9.59/hr. to \$16.00/hr.
Duane Shepard/Chief Water Operator: \$20,000 to \$23,000 annually
