SAMPLE RESOLUTION BY MUNICIPALITY (Locally Administered Project) RESOLUTION NUMBER: 6-2020

Authorizing the implementation, and funding in the first instance of the State-aid Program eligible costs, of a capital project, and appropriating funds therefore.

WHEREAS, a Project for Paving Cooper Road, Rt 104 to CR 85, Town of Hannibal P.I.N. 375692 (the Project") is eligible for funding under a New York State Program administered by the New York State Department of Transportation (NYSDOT); and

WHEREAS, a sum not to exceed \$200,000 in Program Funding is available to progress the project.

WHEREAS, the Town of Hannibal desires to advance the Project by making a commitment of 100% of the State share of the costs of the Design, ROW and Construction

NOW, THEREFORE, the Town Board, duly convened does hereby

RESOLVE, that the Town Board hereby approves the above-subject project; and it is hereby further RESOLVED, that the Town Board hereby authorizes the Town of Hannibal to pay in the first instance 100% of the cost of Design, ROW and Construction work for the Project or portions thereof; and it is further

RESOLVED, that the sum of \$200,000 is hereby appropriated from the <u>Highway Fund</u> and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that in the event the full state share costs of the project exceeds the amount appropriated above, the Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Town Supervisor thereof, and it is further

RESOLVED, that the Town Supervisor of the Town of Hannibal be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for State Aid on behalf of the Town of Hannibal with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the Municipality's/Sponsor's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further

RESOLVED, that a Certified Copy of this resolution be filed with the New York State Commissioner of Transportation of the State of New York by attaching it to any necessary Agreement in connection with the Project between the Town of Hannibal and the State of New York; and it is further

RESOLVED, this Resolution shall take effect immediately.
